Overview of the Vote

Vote Statistics is a \$268 million investment to enable Statistics NZ, as New Zealand's national statistical organisation to:

- increase the efficiency of data collection to reduce the reliance on direct contact with individuals and increasingly utilise administrative data
- deliver data and statistical information, insights, and analysis to enable evidence-based decisions that improve the lives of current and future generations
- advance Māori data aspirations through the Mana Ōrite Relationship Agreement
- ensure enduring and resilient technology systems and capabilities
- prepare for and deliver the five-yearly census of population and dwellings.

The Vote also gives effect to the role as functional leader of the government data system, formalised through the Government Chief Data Steward mandate. Through this role Statistics NZ will lead the data system to achieve the following shifts:

- an inclusive and integrated data system that supports the safe and ethical use of data as a resource across government
- giving effect to the expectations of Te Tiriti o Waitangi through a reciprocal relationship between the Crown, Māori and iwi that supports and contributes to Māori and iwi data needs
- increased public trust and confidence in how government agencies collect, manage and use data.

The Minister for Statistics is responsible for appropriations in the Vote for the 2025/26 financial year comprising:

- over \$72 million for the delivery of data and statistical information services relating to business and the economy
- over \$75 million for delivery of data and statistical information services relating to the population, household economics, social conditions (including child poverty), the labour market, and the environment
- nearly \$37 million for the coordination of statistical and data services for government, through System Leadership of the Official Statistics System (OSS) and Stewardship of the Government Data System; statistical and data management advice; provision of access to official statistics; oversight of the IDI; and the provision of ministerial services
- over \$45 million for the delivery of population and social statistics in accordance with the requirement for the delivery of a census in line with New Zealand and international obligations
- a total of \$22 million for departmental capital expenditure, and
- over \$16 million for Services to Other Agencies including lead agency in shared accommodation with other Crown tenants in Wellington and Christchurch.

1.3 - Analysis of Significant Trends

Output Expenses

Output expenses fluctuate over time in line with expenditure on censuses over the 10-year period. In 2022/23, the actual expenditure is higher than in other years because of an extended 2023 Census operation in response to the impacts of Cyclone Gabrielle. The Delivery of population and social statistics MYA commenced in 2024/25 to deliver the Next Census. Phasing of expenditure will be reviewed to deliver the Next Census successfully.

Capital Expenditure

Expenditure in 2020/21 and 2021/22 was mainly due to the completion of the 8 Willis Street office fit out. Capital expenditure in 2024/25 is largely related to digital projects and is estimated to remain steady from 2025/26 as Stats NZ invests in modernising its core IT systems.

Multi-Category Expenses and Capital Expenditure

Output expenses have risen between 2021/22 and 2023/24, in line with new initiatives and cost pressure funding received to ensure that Stats NZ can continue to produce official statistics. Output expenses have decreased between 2023/24 and 2024/25 due to cost saving initiatives to help achieve a 7.5% reduction in baseline. Output expenses are forecast to increase from 2025/26 due to a shift from quarterly to monthly Consumers Price Index (CPI) reporting.

Note 1 - These measures reflect the commitment to improve the relevance of official statistics by increasing the frequency, quality, accessibility, timeliness, and/or coverage of at least [x number] of releases.

Note 2 - A data release is timely if it is available to customers within the period in which it remains useful. Planned timeliness is a design decision, based on trade-offs with accuracy, response rates and cost. The calendar of release dates for periodical statistical releases is published on the Stats NZ website at least six months in advance, and the achievement of the planned release dates is monitored as a timeliness performance measure. Timeliness releases have been split into critical and other releases to reflect the performance of each release priority.

Note 3 - These measures relate to the number of responses from businesses, households and individuals received in a digital format as part of our commitment to a digitalised government. Measure includes all forms of online engagements - electronic, digital, online and virtual interviewing.

Note 4 - These measures demonstrate satisfaction and experience of customers who use our self-service offerings ie, information releases and data tools which are Infoshare, NZ.Stat and Aotearoa Data Explorer.

Note 5 - This measure demonstrates a change in use of Economic and Business data and tools delivered by Stats NZ. Increased access supports customers to make more informed decisions.

Note 6 - This measure demonstrates timely and complete delivery of the child poverty measures that the Government Statistician is required to produce under The Child Poverty Reduction Act 2018 each financial year as soon as is reasonably practicable, and in any case within the next financial year.

Note 7 - This measure which is indicative of a change in use of Population, Social and Labour Market Data and Statistical Information Services data and tools delivered by Stats NZ. Increased access supports customers to make more informed decisions.

Note 8 - This measure reflects the engagement focus undertaken by Stats NZ with our stakeholders in the government data system. We will produce case studies demonstrating strengthening of the government data system for 2025/26 year and summarise this in the 2025/26 Annual Report.

Note 9 - Overall performance of Ministerial Services provided including OIA requests to the Minister of Statistics for which Stats NZ provides information.

Reasons for Changes in Appropriation

The increase in this appropriation for 2025/26 is mainly due to:

- an increase of \$6.576 million to provide monthly Consumers Price Index (CPI) and more regular reporting of inflation
- an increase of \$3.585 million to fund cost increases such as remuneration and data collection
- an increase of \$1.073 million for improving the timeliness and relevance of child poverty statistics.

Partially offset by:

- a decrease of \$2 million due to one-off funding to support the better use of data for social investment
- a decrease of \$1.505 million for a cost saving initiative to stop an internal learning and capability programme
- a decrease of \$1.500 million for securing the immediate and long-term sustainability of New Zealand's official statistics.
