# Overview of the Vote

The Minister for Māori Crown Relations: Te Arawhiti is responsible for appropriations in the Vote for the 2024/25 financial year covering the following:

- over \$12 million for strengthening Crown capability and supporting significant events that demonstrate and strengthen the Māori Crown relationship
- multi-year appropriation of over \$5 million for the five-year period from 2022/23 to 2027/28 to support upgrades required at Kaitaia Airport, and
- multi-year appropriation of nearly \$4 million for the four-year period from 2024/25 to 2027/28 for the costs associated with the Wakatū Litigation.

The Minister for Treaty of Waitangi Negotiations is responsible for appropriations in the Vote for the 2024/25 financial year covering the following:

- a multi-year appropriation of \$1,400 million for the four-year period from 2024/25 to 2027/28. This appropriation is for the settlement of historical Treaty of Waitangi claims and provides for the payment of redress through the transfer of assets (cash and property) from the Crown to claimant groups and for the payment of interest on the settlements
- over \$36 million for the departmental expenses in settling historical Treaty of Waitangi claims and determining customary interests in the takutai moana (marine and coastal areas)
- over \$12 million for financial assistance to applicants to support determining customary interests in the takutai moana marine and coastal area
- nearly \$6 million for claimant funding to support the settlement of historical Treaty of Waitangi claims
- nearly \$2 million for the operations of Ngāpuhi Investment Fund Limited, and
- \$500,000 for financial assistance to support finalising transfer of ancillary redress.

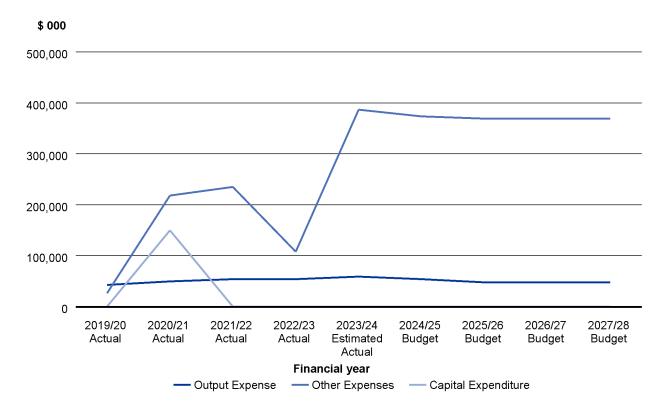

#### Output Expenses

Output expenses remain fairly consistent over the trend period. Yearly time-limited funding has been included between 2019/20 and 2023/24 to support the higher than anticipated demand for determining customary interests. From 2020/21 onwards funding for the operations of Ngāpuhi Investment Fund Limited and Crown Response to Wakatū Litigation and Related Proceedings appropriations have been included in output expenses.

#### Other Expenses

The fluctuation in actual other expenses primarily reflects the size and timing of Treaty Settlements under the Historical Treaty of Waitangi Settlements multi-year appropriation, which varies as each negotiation progresses through key milestones over the full course of the negotiation. Time-limited funding of \$25.200 million is included in 2022/23 for the post-settlement resolution of New Zealand Defence Force Redress at the Royal New Zealand Air Force Base Woodbourne. Additional funding of \$17.300 million is included in 2023/24 to address urgent cost pressures to continue funding the Takutai Moana Financial Assistance Scheme.

# Capital Expenditure

Capital expenditure in 2020/21 relates to the Crown's \$150 million capital investment in the Ngāpuhi Sovereign Fund entity.

## Non-Tax Revenue

The non-tax revenue mainly relates to interest received from lending to implement the Ngāti Whātua Ōrākei Deed of Settlement.

Note 1 - Agreed time is to enable the Minister to meet the ten-day statutory timeframe for providing response.

Note 2 - Te Arawhiti does not have full control over the achievement of these measures as it is partially reliant on claimant groups undertaking the work required by them to achieve a mandate to negotiate, broadly agree to the Crown's offer and move steadily towards the conclusion of negotiations.

Note 3 - Terms of Negotiation is agreed between the Crown and a claimant group. The document outlines the objectives for the negotiations.

Note 4 - An Agreement in Principle is agreed between the Crown and a claimant group. The document describes the broad outline of a settlement package and is signed by the claimant group and the Minister for Treaty of Waitangi Negotiations.

Note 5 - A Deed of Settlement is the complete, detailed and formal settlement agreement between the Crown and the claimant group.

Note 6 - Settlement legislation operationalises the Deed of Settlement.

Note 7 - The performance indicator 'Develop the Marine and Coastal Area (Takutai Moana) Act 2011 Applicant Group Funding scheme updates' was replaced in 2024/25 with 'Implement the Marine and Coastal Area (Takutai Moana) Act 2011 Applicant Group Funding scheme updates' to reflect the transition from planning to implementation.

Note 8 - The performance indicator 'Develop the Marine and Coastal Area (Takutai Moana) Act 2011 legislation updates' was replaced in 2024/25 with 'Implement the Marine and Coastal Area (Takutai Moana) Act 2011 legislation' to reflect the transition from developing legislation updates to implementation.

Note 9 - The nature and complexity of each settlement issue varies widely and can involve a variety of iwi post-settlement governance entities and Crown agencies with settlement responsibilities. Te Arawhiti does not have full control over the achievement of this measure as it is partially reliant on settled groups and the agency with settlement responsibilities to engage in the pathway to resolve each settlement issue.

# Reasons for Change in Appropriation

The decrease in the appropriation for 2024/25 is mainly due to:

- a decrease of \$2 million for time-limited funding for external legal costs related to the Treaty settlement negotiations
- a fiscally neutral adjustment of \$1.285 million to reflect the allocation of Ministry of Justice overhead costs in 2023/24
- a reduction in funding of \$1.250 million to reflect historical underspends within the appropriation
- a net decrease of \$1.061 million for an expense transfer from 2022/23 to 2023/24 and 2024/25 for the Takutai Moana financial assistance scheme to progress rescheduled hearings impacted by court backlogs and from adverse weather events.

This was partially offset by an increase of \$623,000 to ensure core justice services are maintained by improving remuneration for Ministry of Justice employees.
