Overview of the Vote

The Minister for Pacific Peoples is responsible for appropriations in Vote Pacific Peoples for the 2025/26 financial year covering the following:

- services purchased directly from the Ministry for Pacific Peoples:
 - just over \$28 million for the purchase of policy advice, communication, project and relationship services required to maintain strong links between Crown and Pacific communities, and
- other services:
 - just over \$6 million to provide education, employment and skill development programmes for Pacific peoples
 - just over \$6 million to provide Pacific peoples with the information and skills needed to succeed in business
 - just over \$40 million to facilitate home ownership for Pacific peoples
 - just over \$1 million for the promotion of positive role models and the provision of scholarships for further education for Pacific peoples, and
 - \$250,000 for the resourcing of Pasifika Wardens.

The Minister for Pacific Peoples is also responsible for:

Capital expenditure of \$127,000 involves business-as-usual Information Technology replacement only for the Ministry for Pacific Peoples.

Adjustments to the Summary of Financial Activity Table Due to Vote Restructuring

There have been no restructuring adjustments to prior year information in the Summary of Financial Activity table.

1.3 - Analysis of Significant Trends

Non-Departmental Output Expenses decrease from \$60.769 million in 2024/25 to \$54.156 million in 2025/26. The decrease of \$6.613 million is due to:

- a policy initiative that received funding of \$1.363 million in 2022/23 and \$2.023 million in 2023/24, and then a further Contingency drawdown of \$28.611 million in 2023/24, \$35.873 million in 2024/25 and \$40.231 million in 2025/26. This is for Building homes for Pacific People in Porirua (increase of \$4.358 million)
- an October Baseline Update 2023 that received funding of \$41,000 in 2023/24, \$50,000 in 2024/25, \$59,000 in 2025/26, and \$67,000 in 2026/27 & Outyears. This is for Pay Equity settlement for Social Workers (increase of \$9,000)
- a policy initiative in Budget 2023 that received funding of \$1.800 million in 2023/24 and \$1.350 million in 2024/25. This is for Supporting the Growth, Resilience and Sustainability of Pacific Businesses (decrease of \$1,350,000)
- a transfer of time-limited funding of \$630,000 per annum from the Ministry of Housing and Urban Development in 2020/21. This is for the Pacific Financial Capability programme (decrease of \$630,000)
- a policy initiative in Budget 2025 that returns \$22 million over the forecast period for the Tupu Aotearoa programme by realising efficiencies and consolidating government investment into employment support providers (decrease of \$5.500 million)
- a policy initiative in Budget 2025 that returns \$14 million over the forecast period by closing the Tauola Business Fund of the Pacific Economic Development and Pacific Business Trust programme (decrease of \$3.500 million).

Departmental Output Expenses decreases from \$29.288 million in 2024/25 to \$28.407 million in 2025/26. The decrease of \$881,000 million in 2024/25 is due to:

• a policy initiative in Budget 2023 that received funding of \$50,000 in 2022/23, \$2.500 million in 2023/24, \$4.648 million in 2024/25, \$3.767 million in 2025/26 and \$2.350 million in 2026/27 and Outyears. This is for Pacific Languages Strategy - fostering languages and wellbeing in media, education, government and communities (decrease of \$881,000).

Departmental Capital Expenditure decreases from \$144,000 in 2024/25 to \$127,000 in 2025/26 to reflect forecast capital expenditure by the Ministry for Pacific Peoples. This expenditure involves business-asusual Information Technology replacement only.

Note 2 - This is the aggregated score of all the Ministry's stakeholder satisfaction surveys, such as:

- Ministerial satisfaction per the common satisfaction survey
- Ministerial quality of policy advice survey

- Policy secondary advice service survey
- Policy and engagement capability services surveys'
- Annual stakeholder survey.
- Note 3 This includes public events where the Ministry provides funding or support.
- Note 4 This qualitative measure demonstrates the effect of the Ministry's relationships and partnerships work with Pacific communities on government processes that affect them, for example through submissions.
- Note 5 This qualitative measure demonstrates the Ministry's ability to connect Pacific communities with government services, for example emergency responses and opportunities related to government priorities.
- Note 6 This measures the number of government (central and decentralised) staff trained in Kapasa (Pacific Policy Analysis Tool) and Yavu (Foundations of Pacific Engagement tool). The tools build capability in Pacific engagements and ensure consideration of Pacific perspectives and priorities in policy making.

- Note 7 The Ministry's annual stakeholder survey assesses the satisfaction of government (central and decentralised) staff with Pacific policy (Kapasa) and engagement (Yavu) capability services.
- Note 8 The Ministry's annual stakeholder survey assesses the satisfaction of non-government agencies with Pacific engagement capability services.
- Note 9 Timeframe is on a case-by-case basis.
- Note 10 Delivery to the Minister is based on an agreed timeframe that enables their response within 20 working days.
- Note 11 The Ministry will submit a response to the Minister within four working days. The parliamentary timeframe to respond to a Written Parliamentary Question is six working days.
- Note 12 The parliamentary timeframe to lodge Select Committee Questions is specified by Social Services and Community Committee. The timeframe is on a case-by-case basis, as determined by the Social Services and Community Committee.
- Note 13 This qualitative measure demonstrates the outcomes for Pacific peoples participating in the Ministry's programmes that promote healthy homes.[1]
- Note 14 This measures Pacific language broadcasting hours from broadcasting agencies supported by the Ministry.
- Note 15 This measures the total number of likes, comments and shares of Pacific Language Week social media content.
- Note 16 The engagement rate looks at the proportion of interactions (likes, comments, shares) over the total impressions (views) to give an engagement rate by percentage.
- Note 17 The Department of the Prime Minister and Cabinet's Ministerial Policy Satisfaction Survey[2] is used to assess ministerial satisfaction with the Ministry's policy advice.

Note 18 - This indicator provides a standardised score for the technical quality of policy advice. This may include an assessment of clarity, accuracy, analytical rigour, and relevance.

Note 19 - The Ministry's annual stakeholder survey assesses the satisfaction of government agencies with the secondary policy advice they received from the Ministry.

[1] In 2023, over half (56%) of Pacific peoples lived in housing with at least one problem (such as cold, mould, dampness), compared with 32% for the total population. Pacific peoples reported that their homes were always or often cold, and 13% of Pacific peoples at the 2018 Census said their living room was never heated in winter compared with 5% of the total population.
