Reasons for Change in Appropriation

This appropriation has increased by \$4.300 million to \$12.402 million for 2018/19 due to an expense transfer of unused claimant funding from 2017/18.

Contribution to Parihaka community engagement with the Crown support package (M74)

Scope of Appropriation

This appropriation is limited to providing financial support to the Parihaka community to engage in the development and implementation of the Crown support package.

What is Intended to be Achieved with this Appropriation

This appropriation is intended to achieve assistance to the Parihaka community to engage with the Crown in the development of a support package and reconciliation process.

How Performance will be Assessed and End of Year Reporting Requirements

An exemption was granted under s15D(2)(b)(ii) of the PFA as additional information is unlikely to be informative because this appropriation is solely for payments to the Parihaka community.

Reasons for Change in Appropriation

This appropriation has increased by \$150,000 for 2018/19 due to an expense transfer from 2017/18 to provide financial support to the Parihaka community.

Contribution toward Determining Customary Interests in the Marine and Coastal Area (M74)

Scope of Appropriation

This appropriation is limited to providing financial assistance for the investigation of applicant groups' customary rights under the Marine and Coastal Area (Takutai Moana) Act 2011.

Reasons for Change in Appropriation

This appropriation has increased by \$7.291 million to \$12.741 million for 2018/19 due to an expense transfer from 2017/18 to support additional demand for contributions to determining customary interests.

Crown Share in Patunamu Forest Limited (M74)

Scope of Appropriation

This appropriation is limited to the Crown's acquisition of its portion of shares in Patunamu Forest Limited.

An exemption was granted under s15D(2)(b)(ii) of the Public Finance Act as additional performance information is unlikely to be informative because these share purchases form part of the wider historical Treaty of Waitangi settlements.

Reasons for Change in Appropriation

This appropriation has increased by \$2.466 million for 2018/19 due to an expense transfer from 2017/18 to fund the acquisition of shares in Patunamu Forest Limited on behalf of unsettled iwi.

Reasons for Change in Appropriation

This appropriation has increased by \$1.288 million to \$38.836 million for 2018/19 due to:

- an expense transfer of \$1.094 million from 2017/18 to 2018/19 for negotiation costs
- an expense transfer of \$396,000 from 2017/18 to 2018/19 to fund delayed survey work relating to settlements
- an increase of \$375,000 to improve the base pay of Ministry of Justice employees
- a fiscally neutral adjustment of \$178,000 for the Justice Centre lease costs, funded by additional revenue received from building tenants, and
- a fiscally neutral adjustment of \$44,000 for employees seconded to other government agencies.

This was partly offset by:

• a one-off fiscally neutral transfer of \$799,000 in 2018/19 to Vote Justice: Māori Crown Relations appropriation for the establishment of the Office for Māori Crown Relations - Te Arawhiti.
