Reasons for Change in Appropriation

This appropriation increased by \$2.710 million to \$28.760 million for 2023/24 due to:

- a \$3 million increase in cost recoveries from the New Zealand Defence Force
- \$745,000 transferred from 2022/23 for costs delayed due to the timing of project approvals
- \$465,000 funding during the year from the Enhanced Engagement in the Pacific initiative.

These were offset by a transfer of \$1.500 million to New Zealand's contribution to the International Fund for Ukraine.

Reasons for Change in Appropriation

This appropriation decreased by \$44.024 million to \$1,297.845 million for 2023/24 due to a net \$116.524 million of transfers from 2022/23 and to 2024/25 of unused headroom in the appropriation required to accommodate:

- the accounting of potential foreign exchange rate movements affecting the reported New Zealand dollar value of hedged foreign currency expenditure
- the uncertainty of the timing of prepaid monies being recognised as capital expenditure under accounting standards for capabilities being acquired under the United States' Foreign Military Sales programme
- capability project costs deemed uncapitalisable.

This was offset by increases due to:

- the budgets for nine capability projects increasing by a combined \$35.560 million for non-cash technical adjustments to accommodate the increased reported New Zealand dollar value of hedged foreign currency expenditure
- the approval of a new defence capability project of \$27.700 million in 2023/24
- project budget increases of \$5.308 million for supplier liquidated damages claims. These additional costs are borne by the suppliers
- realignment of tasks within a capability project between the Ministry and the New Zealand Defence Force resulting in an increase of \$3.932 million in 2023/24.
