Scope of Appropriation

This appropriation is limited to evaluations of national and local education programmes and providers and to evaluation services provided to third parties under contract.

#### Reasons for Change in Appropriation

This appropriation increased by \$583,000 to \$40.041 million for 2023/24 due to new funding of \$1.663 million from 2023/24 onwards to meet the costs of the Public Service Pay Adjustment.

This increase was partially offset by a decrease of \$1.080 million due to an expense transfer from 2023/24 to 2024/25 to meet cost pressures relating to baseline savings, manage future cost pressures, and system improvements to enable operational efficiencies.

#### Independent Monitoring and Assurance of the Oranga Tamariki System (M63) (A8)

#### Scope of Appropriation

This appropriation is limited to independent monitoring of compliance with, and delivery of, the Oranga Tamariki system and related regulations and standards.

#### Reasons for Change in Appropriation

This appropriation increased by \$10,000 to \$11.578 million for 2023/24 due to funding for the Public Sector Pay Adjustment of \$300,000.

The increase in this appropriation is mostly offset by a decrease of \$290,000 due to an expense transfer to 2024/25 to meet cost pressures relating to baseline savings and for system improvements.
