Scope of Appropriation

This appropriation is limited to the functions of the Aged Care Commissioner

Reasons for Change in Appropriation

This appropriation increased by \$81,000 to \$2.104 million for 2023/24 due to additional funding through Budget 2022 contingency drawdown to address price and demographic pressures for the Aged Care Commissioner.

Delivering hauora Māori services (M36) (A21)

Scope of Appropriation

This appropriation is limited to developing, implementing and delivering hauora Māori services, supporting the development of hauora Māori providers, developing partnerships with iwi, commissioning kaupapa Māori services and other services developed for Māori, and other related services.

Reasons for Change in Appropriation

This appropriation increased by \$88.566 million to \$704.106 million for 2023/24 due to:

- \$34.704 million of additional funding through Budget 2022 contingency drawdown to address price and demographic cost pressures
- \$25 million for a fiscally neutral transfer from the Delivering Primary, Community, Public and Population Health Services appropriation to enable the Winter Wellness Immunisation programme to be delivered through the Whanau Ora Commissioning Agency and hauora Māori partners
- \$17.250 million for a fiscally neutral transfer from the Delivering Primary, Community, Public and Population Health Services appropriation to enable the commissioning of Te Ao Māori models of maternity and early years care
- \$12.879 million for a fiscally neutral transfer from the Delivering Primary, Community, Public and Population Health Services appropriation to fund the Māori Kaiāwhina roles as part of the comprehensive primary care teams
- \$9.914 million for a fiscally neutral transfer from the Delivering Primary, Community, Public and Population Health Services appropriation to cover the costs of the contracts with Māori health providers as part of the funding for improving pay relativities for funded sector health workers
- \$4.186 million for a fiscally neutral transfer from the Delivering Primary, Community, Public and Population Health Services appropriation to implement the pay equity extension for 28 providers who undertake social work or work that is substantially similar

- \$3.190 million for a fiscally neutral transfer from the Delivering Primary, Community, Public and Population Health Services appropriation to fund the Māori Providers for the Well Child Tamariki Ora Enhanced Support Pilots in Lakes, Counties Manukau and Tairāwhiti
- \$2.758 million for a fiscally neutral transfer from the Delivering Primary, Community, Public and Population Health Services appropriation to cover the costs of engaging with the Iwi Māori Partnership Boards for the service integration of locality provider networks
- \$2.289 million for a fiscally neutral transfer from the Delivering Primary, Community, Public and Population Health Services appropriation to cover the costs of contracts with hauora Māori providers for the Integrated Primary Mental Health and Addictions programme
- \$2 million for a fiscally neutral transfer to reflect the expected increase in costs relating to the alcoholrelated programmes with corresponding revenue from New Zealand Customs Service
- \$2 million for a fiscally neutral transfer from the Delivering Primary, Community, Public and Population Health Services appropriation to cover the workforce development cost for the Māori Kaiāwhina roles
- \$1.650 million for a fiscally neutral transfer from the Delivering Hospital and Specialist Services appropriation for Kaupapa Māori specialist mental health services through contracts with Māori health providers
- \$800,000 for a fiscally neutral transfer from the Delivering Primary, Community, Public and Population Health Services appropriation for the workforce development and enablers to support the Kaupapa Māori specialist mental health services
- \$787,000 for a fiscally neutral transfer from the Delivering Primary, Community, Public and Population Health Services appropriation to ensure the policy advice and operational planning of New Zealand's future quarantine and isolation capability improves equity and outcomes for Māori
- \$760,000 for a fiscally neutral transfer from the Delivering Primary, Community, Public and Population Health Services appropriation to fund Māori Primary Health Organisations to participate in locality provider network design
- \$400,000 of additional funding for the hauora Māori connection and coordination team in Auckland to support safe transitions from health services to housing and community support, and
- \$215,000 of additional funding to implement the pay equity extension for identified employees in community and iwi organisations who undertake social work or work that is substantially similar.

This increase was partly offset by:

- \$31.500 million for the return of funding in Budget 2024 due to the disestablishment of the Te Aka Whai Ora | Māori Health Authority, and
- \$716,000 for a fiscally neutral transfer to the Stewardship of the New Zealand health system MCA to reflect some of Te Aka Whai Ora | Māori Health Authority's functions being transitioned to the Ministry of Health | Manatū Hauora from April 2024 as part of the disestablishment of the Te Aka Whai Ora | Māori Health Authority.

The measure adjustments in this appropriation have been made to accurately reflect what is being measured. These reflect the Service performance reporting standard (PBE FRS 48) principles for faithful representation and understandability.

Two measures regarding accepted referral for CT scans and MRI scans appeared twice inadvertently in the 2023/24 estimates. These measures were discontinued but reappeared at the end of the appropriation. This discontinuation confirms their removal for good.

Reasons for Change in Appropriation

This appropriation increased by \$1,669.078 million to \$14,389.512 million for 2023/24 due to:

- \$764.719 million of additional funding through Budget 2022 contingency drawdown to address price and demographic cost pressures
- \$685.842 million of additional funding for the settlement of the nurses pay equity claim
- \$110 million carried forward from 2022/23 to help clear the backlog of Planned Care that arose through the height of the COVID-19 pandemic
- \$54.550 million for a technical adjustment to fund changes in Health New Zealand | Te Whatu Ora's capital charge payments following the revaluation of the assets
- \$19.828 million of additional funding to support the investment in data and digital priority areas that enable improvements in health system performance
- \$17 million carried forward from 2022/23 to support the Regional Hospital Redevelopment programme, reflecting the rephasing of the programme
- \$15 million carried forward from 2022/23 to support the project delivery acceleration work for the Mental Health Infrastructure Programme, reflecting the rephasing of the programme
- \$12.215 million of additional funding to fund an interim pay adjustment as part of the Health New Zealand | Te Whatu Ora midwives' pay equity claim settlement
- \$5.150 million carried forward from 2022/23 to fund the cost of the demolition of the old Christchurch Energy Centre building in 2023/24
- \$4 million of additional funding for Health New Zealand | Te Whatu Ora to support the remediation and stabilisation of immediate payroll system risks, and
- \$130,000 for a fiscally neutral transfer from Vote Courts to cover the cost of the second Pou Oranga role that is overseen by Health New Zealand | Te Whatu Ora.

This increase was partly offset by:

- \$8 million for a transfer to 2024/25 and 2025/26 for the Regional Hospital Redevelopment Programme, reflecting the rephasing of the programme
- \$4 million for a transfer to 2024/25 and 2025/26 for the project delivery acceleration work for the Mental Health Infrastructure Programme, reflecting the rephasing of the programme
- \$3.900 million for a transfer to 2024/25 in Budget 2024 for a national Mental Health and Addiction Community Sector Innovation Fund which will enable community organisations to submit proposals for innovative new approaches to addressing the mental health and wellbeing needs of New Zealanders
- \$1.806 million for a fiscally neutral transfer to the Whaikaha | Ministry of Disabled people for the costs of two contracts relating to intellectual disability services, and
- \$1.650 million for a fiscally neutral transfer to the Delivering hauora Māori services appropriation for the Kaupapa Māori specialist mental health services.

- \$9.895 million of additional funding for Tranche 3 of the Health Sector Agreements and Payments Programme
- \$8.520 million for a fiscally neutral transfer to reflect the expected increase in costs relating to the alcohol-related programmes with corresponding revenue from New Zealand Customs Service
- \$5 million carried forward from 2022/23 to support the coordination and implementation of the support workers' pay equity process
- \$1.003 million of additional funding for Health New Zealand | Te Whatu Ora to continue the pilots providing accommodation and support for people leaving mental health and addiction inpatient care

- \$608,000 carried forward from 2022/23 to contribute to planned alcohol harm reduction work in 2023/24
- \$150,000 of additional funding for Health New Zealand | Te Whatu Ora to provide education and training for providers on how to support communities, households and whānau in regions affected by the North Island extreme weather events, and
- \$150,000 of additional funding for Health New Zealand | Te Whatu Ora to undertake a short review to identify additional support, particularly health support that emergency housing clients need in Rotorua.

This increase was partly offset by:

- \$12.879 million for a fiscally neutral transfer to the Delivering hauora Māori services appropriation to fund the Māori Kaiāwhina roles as part of the comprehensive primary care teams
- \$10 million for a transfer to 2024/25 for the BreastScreen Aotearoa (BSA) Critical Infrastructure Replacement programme, reflecting the rephasing of the programme
- \$9.914 million for a fiscally neutral transfer to the Delivering hauora Māori services appropriation to cover the costs of the contracts with Māori health providers as part of the funding for improving pay relativities for funded sector health workers
- \$5.820 million for a transfer to 2024/25 in Budget 2024 for a national Mental Health and Addiction Community Sector Innovation Fund which will enable community organisations to submit proposals for innovative new approaches to addressing the mental health and wellbeing needs of New Zealanders
- \$5 million for a fiscally neutral transfer to the Stewardship of the New Zealand health system MCA for the Ministry of Health | Manatū Hauora to support the coordination and implementation of the support workers' pay equity process
- \$4.200 million for a transfer to 2024/25 for the development of a national public health operating information system, reflecting the rephasing of the project
- \$4.186 million for a fiscally neutral transfer to the Delivering hauora Māori services appropriation to implement the pay equity extension for 28 providers who undertake social work or work that is substantially similar
- \$3.190 million for a fiscally neutral transfer to the Delivering hauora Māori services appropriation to fund the Māori Providers for the Well Child Tamariki Ora Enhanced Support Pilots in Lakes, Counties Manukau and Tairāwhiti
- \$2.758 million for a fiscally neutral transfer to the Delivering hauora Māori services appropriation to cover the costs of engaging with the Iwi Māori Partnership Boards for the service integration of locality provider networks

- \$2.289 million for a fiscally neutral transfer to the Delivering hauora Māori services appropriation to cover the costs of contracts with hauora Māori providers for the integrated primary mental health and addictions programme
- \$2 million for a fiscally neutral transfer to the Delivering hauora Māori services appropriation to cover the workforce development cost for the Māori Kaiāwhina roles
- \$800,000 for a fiscally neutral transfer to the Delivering hauora Māori services appropriation for the workforce development and enablers to support the Kaupapa Māori specialist mental health services
- \$787,000 for a fiscally neutral transfer to the Delivering hauora Māori services appropriation to ensure the policy advice and operational planning of New Zealand's future quarantine and isolation capability improves equity and outcomes for Māori, and
- \$760,000 for a fiscally neutral transfer to the Delivering hauora Māori services appropriation to fund Māori Primary Health Organisations to participate in locality provider network design.

Monitoring and Protecting Health and Disability Consumer Interests (M36) (A21)

Scope of Appropriation

This appropriation is limited to the provision, purchase, and support of services that monitor and protect health and disability consumer interests.

Reasons for Change in Appropriation

This appropriation increased by \$1.572 million to \$41.123 million for 2023/24 due to additional funding through Budget 2022 contingency drawdown to address price and demographic pressures for health entities including the Health and Disability Commissioner | Te Toihau Hauora, Hauātanga, the Health Quality and Safety Commission | Te Tāhū Hauora, and the Mental Health and Wellbeing Commission | Te Hiringa Mahara.

National Management of Pharmaceuticals (M36) (A21)

Scope of Appropriation

This appropriation is limited to services relating to the national management of pharmaceuticals.

Reasons for Change in Appropriation

This appropriation increased by \$1.535 million to \$29.907 million for 2023/24 due to:

- \$1.135 million of additional funding through Budget 2022 contingency drawdown to address price and demographic pressures for Pharmac | Te Pātaka Whaioranga, and
- \$400,000 for a fiscally neutral transfer from the Implementing the COVID-19 Vaccine Strategy MCA to cover Pharmac | Te Pātaka Whaioranga's distribution costs of COVID-19 vaccine and treatments.

National Pharmaceuticals Purchasing (M36) (A21)

Scope of Appropriation

This appropriation is limited to purchasing pharmaceuticals on the national pharmaceutical schedule and subsidising the supply of pharmaceuticals not on the national pharmaceutical schedule.

Reasons for Change in Appropriation

This appropriation increased by \$495.211 million to \$1,806.211 million for 2023/24 due to:

- \$449.631 million for fiscally neutral transfers from the Implementing the COVID-19 Vaccine Strategy MCA to transition the COVID-19 vaccine and treatments funding into the Combined Pharmaceutical Budget (CPB) held by Pharmac | Te Pātaka Whaioranga, and
- \$45.580 million of additional funding, including \$21.800 million transferred from the Delivering Primary, Community, Public and Population Health Services appropriation and \$23.780 million provided through Budget 2024, to allow for an increase in demand for medicines resulting from the removal of the \$5 prescription co-payments for all New Zealanders over the age of 14.

Problem Gambling Services (M36) (A21)

Scope of Appropriation

This appropriation is limited to the provision, purchase, and support of services that minimise the harm from gambling, in accordance with the Gambling Act 2003.

Reasons for Change in Appropriation

This appropriation increased by \$3.530 million to \$29.557 million for 2023/24 due to:

- \$2.592 million carried forward from 2022/23 to develop and implement the integrated three-year problem gambling strategy, reflecting the rephasing of the programme
- \$735,000 carried forward from 2022/23 to support research related investment for problem gambling services, and
- \$203,000 for a fiscally neutral transfer from the Stewardship of the New Zealand health system MCA to adjust the allocation of problem gambling funding between the Ministry of Health | Manatū Hauora, Health New Zealand | Te Whatu Ora and the Te Aka Whai Ora | Māori Health Authority.

3.4 - Non-Departmental Other Expenses

International Health Organisations (M36) (A21)

Scope of Appropriation

This appropriation is limited to the Crown funding New Zealand's World Health Organization (WHO) membership and contributing to specific WHO projects.

Reasons for Change in Appropriation

This appropriation increased by \$500,000 to \$2.730 million for 2023/24 reflecting a fiscally neutral transfer from the Stewardship of the New Zealand health system MCA to cover the cost pressures for the WHO memberships and related projects.

Legal Expenses (M36) (A21)

Scope of Appropriation

This appropriation is limited to funding the defence and settlement of health-related or disability-related legal claims against the Crown.

Reasons for Change in Appropriation

This appropriation increased by \$600,000 to \$1.808 million for 2023/24 reflecting a fiscally neutral transfer from the Stewardship of the New Zealand health system MCA to cover the cost pressures for legal expenses resulting from new proceedings, ongoing historic abuse claims, and COVID-19 litigation.

Loss on sale of Crown-owned assets (M36) (A21)

Scope of Appropriation

This appropriation is limited to the loss on sale incurred when disposing of Crown-owned assets.

- \$6 million carried forward from 2022/23 for the implementation of the fluoridation subsidy scheme, reflecting the rephasing of the programme
- \$5 million for a fiscally neutral transfer from the non-departmental output expense Delivering Primary, Community, Public and Population Health Services appropriation to support the coordination and implementation of the support workers' pay equity process
- \$4.190 million for a fiscally neutral transfer to reflect the additional IT and facilities expenses incurred by the Ministry of Health | Manatū Hauora on behalf of Health New Zealand | Te Whatu Ora and the corresponding revenue recovery received
- \$2.667 million of additional funding to provide for the one-off cost of delivering the IT platform required to underpin the Assisted Dying Service in 2023/24 only
- \$980,000 for a fiscally neutral transfer to reflect the expected increase in costs relating to the alcoholrelated programmes with corresponding revenue from New Zealand Customs Service

- \$964,000 for the return of the Ministry of Health | Manatū Hauora's share of the Partnership Governance Group funds from the Health Research Council of New Zealand
- \$716,000 for a fiscally neutral transfer from the non-department output expense Delivering hauora Māori services appropriation to reflect some of Te Aka Whai Ora | Māori Health Authority's functions being transitioned to the Ministry of Health | Manatū Hauora from April 2024 as part of the disestablishment of the Te Aka Whai Ora | Māori Health Authority
- \$714,000 carried forward from 2022/23 to contribute to planned alcohol harm reduction work in 2023/24
- \$550,000 carried forward from 2022/23 to continue the National Radiation Storage Facility -Replacement and Relocation project, reflecting the rephasing of the project
- \$480,000 for a fiscally neutral transfer reflecting the increase in costs to support public health medicine placements and the corresponding increase in revenue recovery from New Zealand College of Public Health Medicine
- \$400,000 for a capital to operating swap to cover additional operating costs including transportation and encapsulation for the replacement and relocation of the National Radiation Storage facility
- \$232,000 carried forward from 2022/23 to support the Ministerial Advisory Committee for Health Reform Implementation
- \$200,000 carried forward from 2022/23 to support the problem gambling harm related work carried out by the Ministry of Health | Manatū Hauora, and
- \$100,000 for a fiscally neutral transfer to reflect the increase in costs associated with the Point of Consumption Charges and the corresponding increase in revenue recovery from the Department of Internal Affairs.

This increase was partly offset by:

- \$18.077 million for the return of DHB sustainability funding as part of a package of short-term savings
- \$2.575 million for a transfer to 2024/25 in Budget 2024 for the independent cost benefit analysis and business case development for Waikato New Medical School
- \$2.319 million for a transfer to 2024/25 reflecting the rephasing of the project for the development of the Group A Streptococcus vaccine
- \$2 million for a transfer to 2024/25 for the Ministry of Health | Manatū Hauora to continue engaging with experts on the final stages of the Holidays Act Remediation programme and ensure appropriate assurance processes are in place
- \$1.500 million for the return of COVID-19 funding due to the revocation of COVID-19 mask and isolation mandates and the reset and resize of other COVID-19 operational activities and services
- \$964,000 for a transfer to 2024/25 to enable the evaluation work for the smoking-reduction plans
- \$704,000 for a fiscally neutral transfer to Vote Tertiary Education and Vote Revenue to support an additional 50 medical school places
- \$600,000 for a fiscally neutral transfer to the non-departmental other expense Legal Expense appropriation to cover the cost pressures resulting from new proceedings, ongoing historic abuse claims, and COVID-19 litigation

- \$500,000 for a fiscally neutral transfer to the non-departmental other expense International Health Organisations appropriation to cover the cost pressures for the WHO memberships and related projects, and
- \$203,000 for a fiscally neutral transfer to the non-departmental output expense Problem Gambling Services appropriation to adjust the funding allocation between the Ministry of Health | Manatū Hauora, Health New Zealand | Te Whatu Ora and the Te Aka Whai Ora | Māori Health Authority for the Problem Gambling.
