Reasons for Change in Appropriation

This appropriation increased by \$22.886 million to \$95.854 million for 2023/34 due to:

- increase of \$23.697 million for community law centres due to surplus interest generated from the lawyers and conveyancers' special fund
- an expense transfer of \$1.456 million from 2022/23 to 2023/24 for masjidain attack victim assistance scheme grants
- an expense transfer of \$500,000 from 2022/23 to 2023/24 for the carry forward of underspent funding from the offender levy, and
- an increase of \$133,000 for remuneration of social workers and employees undertaking social work in community and iwi organisations, aiming to achieve pay equity.

This was partially offset by:

- a fiscally neutral adjustment of \$2.400 million to Vote Courts to address cost pressures for Court and Coroner related costs, and
- a fiscally neutral adjustment of \$500,000 for post implementation activities of Whakaorangia te Mana Tangata to support Māori offenders, victims and their whānau that will be provided under the Ministry of Justice departmental activities.
