Note 1 - Measure withdrawn as it does not meet the current reporting standard and the development of a new measure is being considered.

Note 2 - This is a new performance indicator and was selected as pageviews on the data.govt.nz website are a proxy for information being sought and used across the data system. The data.govt.nz website, administered by the Government Chief Data Steward (GCDS), is the primary information website across the data system and provides other agencies and the public the latest information and tools and provides a vehicle for agencies to interact with the system and upload their data sets. The standard is based on the 2021/22, 2022/23 baseline and estimated result for 2023/24.

Reasons for Change in Appropriation

This appropriation increased by \$771,000 to \$192.026 million for 2023/24 due to:

- an increase of \$741,000 in expense transfers due to an underspend in 2022/23 to provide sustainable, quality data for generations to come, and
- an increase of \$30,000 for the provision of data to the International Monetary Fund that helps meet Treasury's obligations.
