This appropriation decreased by \$15.193 million to \$550,000 for 2024/25 due to:

- a decrease of \$7.346 million for management, clearance and assistance of land and built structures due to:
 - a return of the residual funds of \$4.395 million to the Centre
 - a fiscally neutral transfer of \$3 million to Land Liabilities under the Property Rights MCA to fund the cost of fixing the Napier Prison retaining wall in 2024/25 approved in Budget 2025
 - offset by an expense transfer of \$49,000 from 2023/24 to align expenditure with the timing of the remaining work programme
- a decrease of \$3.148 million for acquisition and disposal of land and improvements due to:
 - a return of the residual funds of \$3.348 million to the Centre
 - offset by an expense transfer of \$200,000 from 2023/24

Note 1 - This measure was removed in 2024/25 because funding ended in June 2024.

Note 2 - This measure was removed in 2024/25 because the measure is no longer able to be met due to reduction of budget and increasing building and construction costs of around 40%. This measure was replaced by the new measure. The number of planned works over \$20,000 completed for Crown Managed properties is delivered to plan which is 50 houses'.

Note 3 - This is a new performance measure for 2024/25 and was selected because the measure demonstrates management across the portfolio of properties owned by LINZ (of which regional housing improvement programme is only a proportion of these). This measure replaced the measure 'The number of houses with remediation work completed under the regional housing improvement programme.'

Note 4 - This is a new performance measure for 2024/25 and has been added to support the outcome of a well-managed Crown Estate.

Note 5 - The budget standard was changed for 2024/25 from 90% to 60%. This change was required as part of the government mandated 6.5% savings initiatives that took effect from Budget 2024.

Note 6 - The measure wording was changed for 2024/25 from 'Outstanding rent for Land Information New Zealand-managed Crown properties is no more than 4% of total rental revenue' to 'Revenue collected on time for Land Information New Zealand-managed Crown properties is higher than 90% of total Revenue.'

Reasons for Change in Appropriation

This appropriation increased by \$14.718 million to \$74.686 million for 2024/25 due to:

- Crown land management expenses category increased by \$6.999 million to \$54.420 million due to an expense transfer of \$3.569 million from 2023/24 (which includes \$1.700 million of Watts Peninsula due to delays in the work establishing a reserve, \$1 million due to delay in work to convert and transfer acquisition of Fresh and Sea Water Areas to Crown ownership due to legislation amendment and \$869,000 for delays in Regional Housing Improvement work programmes due to contractor availability)

- regional elevation data capture delivery increased by \$814,000 as a result of an expense transfer from 2023/24 due to adverse weather conditions and industry capacity resulting in delays in data capture and data processing.
