Description: This initiative provides funding to enhance New Zealand's five-yearly

programme of engagement with the Association of South East Asian Nations (ASEAN) under the ASEAN-New Zealand Plan of Action. In recognition of ASEAN's role as a market for New Zealand and its growing importance to our international interests, it proposes a set of activities and programmes designed to grow our influence with the ten-country ASEAN bloc, safeguard our access to peak regional decision-making forums, and improve ASEAN's ability to support New Zealand's own international priorities. Other benefits include better trade access to key Southeast Asian markets, and more effective regional action on security priorities such as countering terrorism, transnational crime and climate change over the next five years.

Description: This initiative provides for the establishment of a single new Multi Year

Appropriation (MYA), International Development Cooperation, for the

triennium 2021/22 to 2023/24, converting and transferring three years of funding from the existing annual baseline, International Agency Cooperation, to the new MYA. The three-year value of the transfer is \$2,538.709 million. This also provides for the continuation of the existing annual baseline, International Development Cooperation, for the 2024/25 financial year with an appropriation

of \$860.955 million.
