BUDGET 2024 – Capital Initiatives

Thank you for your letter of 25 January 2024 concerning your expectations as they relate to capital initiatives in Budget 2024. In response, the following sets out two bids as they relate to cost pressures and new capital initiatives within the Ministry of Foreign Affairs portfolio. These bids are included in the attached capital proposal templates.

2. Pacific Property Programme (cost pressure). [33] capital plus associated operating expenditure

The Ministry received additional funding though Budget 2020 (\$47.8 million capital and \$14.7 million operating funding), albeit less than half the total funding bid for, to implement a programme of major property and infrastructure refurbishments and replacements to lift the standard, performance, and health safety and compliance of the Ministry's properties across the Pacific.

These are now in delivery or advanced planning and the Ministry is incurring significant cost pressures for these projects. Projects within the programme have also been brought forward to take advantage of mobilised New Zealand contractors and resources and to mitigate future cost pressures.

Scott Base

Your letter also referenced work under way to reassess the funding pathway as it relates to the redevelopment of Scott Base. Treasury and MFAT officials have been working with Antarctic New Zealand and will submit a separate bid as part of the Capital Pipeline Review for consideration.

Funding constraints

In submitting these bids I would note that the Ministry of Foreign Affairs and Trade is currently unable to reprioritise capital expenditure to fund these costs. Capital funding is constrained already largely because of the way the Ministry (like all Government agencies) is funded for capital, with the primary funding source being depreciation. This is very significant for MFAT because the majority of their assets are property.

Factors such as cost escalation and the all of government instruction to move to as-a- Service for information technology solutions (specifically the accounting implications of that change and the capital funding impact of that) exacerbate the problem.

MFAT has also been required to fund significant new property assets (Abu Dhabi, Guangzhou, Yangon, Bridgetown and Honolulu) and significant replacement assets (Beijing, Canberra and Riyadh) from existing funding. Notably, this was also the case for their new head office fit for which funding was sought but not provided.
