- [35] 9(2)(g)(ii) to maintain the effective conduct of public affairs through protecting ministers, members of government organisations, officers and employees from improper pressure or harassment;
- [36] 9(2)(h) to maintain legal professional privilege
- [37] 9(2)(i) to enable the Crown to carry out commercial activities without disadvantage or prejudice
- [38] 9(2)(j) to enable the Crown to negotiate without disadvantage or prejudice
- [39] 9(2)(k) to prevent the disclosure of official information for improper gain or improper advantage
- [40] 18(c)(i) that the making available of the information requested would be contrary to the provisions of a specified enactment

Did Treasury advise the Minister not to publish outyear allowances? Is this PFA compliant?

- We are currently advising the Government on outyear allowances.
- As the Minister said at the BPS release, given the current level of uncertainty she will make decisions on outyear allowance once she has received final economic and fiscal forecasts.
- The PFA does not require publishing outyear allowances in the BPS but in line with convention the Minister stated that her B24 allowance would be no more than \$3.5 billion.

Thanks. I've just trawled back through the past BPS docs.

BPS 2010 was published in April <u>Budget Policy Statement 2010 | The Treasury New Zealand</u> but that is an outlier. While there have been a few published in Feb/March e.g. 1997, 1998, 2000, 2002, 2012, 2021 this years is definitely quite late historically.

I also think its reasonably safe to say not publishing allowances is very rare. Looking back through the BPS's, I had to go back to 2002/2003 to find where we hadn't set out operating allowances/allocations.
