Auckland Pacific Skills Shift (ID: 15610)

Initiativa

5. You agreed to remove savings from the Auckland Pacific Skills Shift (T2024/874 refers), but indicated you wished to speak to the responsible Minister. You may wish to follow up with Minister Lee about this initiative (in her capacity as the Minister of Economic Development).

Transport – licence subsidy (ID: 15691)

- 6. You recently asked to understand the impact of the 'older drivers licence subsidies' portion of Waka Kotahi/New Zealand Transport Agencies' baseline reduction initiative (ID 15691). This initiative is part of a wider 5% reduction proposed for the Land Transport Regulatory Services Appropriation.
- 7. Older drivers have to renew their licence more frequently than other drivers. In recognition of this, there is a subsidy on the cost of renewing licences. The impact of this savings proposal would see older drivers paying approximately 65 cents extra when renewing their license.

8. We estimate that the savings from this element of the initiative are approximately \$0.072 million (\$72k). We can request that this additional detail is firmed up with Waka Kotahi, if required.

Reduced savings from Public Service Commission

9. As part of the further savings exercise, the Public Service Commission (PSC) advised it may be able to provide a one-off saving of up to \$1 million in 2024/25. This was based on PSC moving quickly to a new sustainable and affordable size. [33]

As a result, PSC proposes reducing the one-off saving from \$1 million to \$0.3 million total operating. This would give them an additional \$0.7 million in 2024/25 to ensure the transition can be achieved without the risk of going unappropriated. PSC have noted that they will return any unspent funding from transition costs in 2024/25 if they don't eventuate as planned.

Waste Disposal Levy - realising targeted policy savings for Budget 2024

Savings Proposal

A Cabinet paper on the Waste Disposal Levy (waste levy) that is no longer being progressed would have generated \$104 million in savings for Budget 2024. The Treasury vote team received a copy of this Cabinet paper during agency consultation stage. We understand that Budget Ministers are still interested in progressing options for the Waste Disposal Levy at Budget 2024.

The Cabinet paper proposed to expand the scope of the waste levy, enabling activities that are currently funded in separate appropriations to be funded from within the waste minimisation appropriation. This then allows for a reduction of those separate appropriations (as that activity is now in scope of levy funding) thus generating savings. Expanding the scope of the levy will require legislative change which would be possible through Budget night legislation.

The \$104 million savings are split between the Waste Disposal Levy targeted savings initiative and the Waste Minimisation baseline savings initiative. The Waste Minimisation initiative is currently scaled in the Budget package (\$26.388 million total operating). Progressing the waste levy proposal would mean this initiative can be included in full (an additional \$25.584 million total op), and \$61.83 million in savings can be included against the Waste Disposal Levy initiative (that is not currently in the package).

Pending final decisions, we note the estimated waste levy expansion impact on savings is:

^{*}The Waste Minimisation initiative includes components (\$9.688m) not impacted by changes to the waste levy scope that are currently included in the Budget package (\$26.388 million total operating). If the scope expansion is agreed, the total savings for the initiative would be \$51.972 million.

Options to progress decisions

If you wish to include waste levy savings in Budget 2024, Cabinet decision is required seeking agreement to the expand the levy scope. There are two options to progress this:

1. A separate Cabinet paper considered by a Cabinet committee no later than 15 April (Treasury recommended) or,

2. The policy decision is included in the Budget 2024 Cabinet paper on 29 April 2024.

You also asked about a separate Cabinet paper going to Cabinet on 29 April alongside the Budget Cabinet paper. Given the need for certainty on the final Budget package in the Budget Cabinet paper, we do not recommend this approach. Separate papers increase the risk that a decision is taken on the waste levy contrary to that reflected in the Budget package.

We also understand Environment Ministers may still be considering a broader range of options, including further expansion of the waste levy scope, and increasing the levy. To ensure savings are realised for 2024/25, we strongly recommend that for Budget 2024 the proposal is limited to the expansion of the scope as described above. [33]

At Budget Ministers 4, we recommend confirming an approach to and timing of the Cabinet paper that allows savings to be realised from an expansion of the waste levy scope at Budget 2024. This will also need to be discussed with Minister Simmonds.

Annex 4: More information about Partnership Schools and Ministry for Regulation

Relevant initiatives

- ID 15799: Partnership Schools (Charter schools | Kura Hourua)
 Operating \$38.2m (per annum)
- In keeping with the Coalition Agreement between the New Zealand National Party and Act New Zealand, new Charter schools | kura hourua (partnership schools) will be created and State schools will have the option to become charter schools.
- The current Treasury recommendation provides funding for the establishment of up to 15 new charter schools and the conversion of up to 35 State schools into charter schools along with appropriate support over the forecast period. This level of funding enables a balance to be stuck between affordability and deliverability. Schools will be opened as proposals are approved.
- The Departmental Agency (DA) model agreed following recent Cabinet decisions increases costs. Costings are still subject to confirmation but the \$4.0 million of recommended funding provided balances the additional costs needed against the high bar for new FTE. This funding would cover the costs of a Chief Executive and a small number of additional staff to deliver the work of the DA (final staff numbers will be subject to further work by the Ministry of Education and the DA on exact staffing requirements) and for the DA to engage with schools to stimulate demand for the programme and implement contracts with schools.

- ID 15734: Ministry for Regulation Establishment and ongoing funding Operating \$3.8m (per annum), Total Capital \$2.0m
- This initiative provides funding to establish and operate a new Ministry for Regulation. This funding is in addition to the reprioritised funding from:
 - o the Productivity Commission (\$5.7m p/a),
 - Treasury (\$1.7m p/a), and
 - o Ministry of Business, Innovation and Employment (\$0.3m p/a).
- This means the total budget for the Ministry of Regulation is approximately \$12m p/a with costs slightly front-loaded in 2024/25.
- o This level of funding will enable an agency of 42 FTE.
- The additional funding will enable the Ministry to undertake new functions, including undertaking regulatory sector reviews and ensuring compliance with new regulatory principles. It will enable the Ministry to expand existing functions, including quality assurance of regulatory impact statements.

Annex 5: Independent Rapid Reviews Talking Points

- I now have the final IRR reports and have referred these onto you.
- Positively, the Reviewers confirmed that agencies had done a good job, and Reviewers did not identify significant additional savings for Budget 24 – but were generally supportive of the savings packaged proposed.
- There are two savings proposals identified:
 - MfE proposal relating to Kaipara Moana Remediation Funding \$3.2 million per annum, and
 - MBIE proposal largely relating to closing contestable funds \$84.5 million per annum.
- Treasury supports the Kaipara Moana proposal and the MBIE proposal but recommends
 deferring consideration of the MBIE proposal until after Budget 2024. This is because
 confirming savings would require a process of engagement with portfolio Ministers and
 Crown Entities which may not be proportionate or achievable within the tight timeframes
 for agreeing the package.
- [Depending on conversation with Minister Seymour about MBIE proposal and the Minister for the environment about the Kaipara Moana proposal]: This means that the overall budget package will incorporate savings of an additional \$3.2 million per annum from the MfE proposal.
- The Reviews identified a range of recommendations for possible savings post Budget 2024. It is my intention to request the responsible or agency Minister provide me with a 'Response' plan to enable these recommendations to be progressed further. These will feed into phase two of the fiscal sustainability programme which I will be receiving advice on shortly.
